Polluted Air in Bosnia and Herzegovina

- Tuzla, the second most polluted city in Europe*
- Sarajevo the most polluted capital of Europe*
- High air pollution levels also registered in Zenica, Lukavac, Prijedor, Banjaluka, Kakanj, ...

December 2013., Air Pollution Episode in Sarajevo

- 5 days with hazardous levels of PM10 (per US EPA standard)
- How authorities reacted:
 - "air pollution the cost of urban living", Federal Hydro-Meteorogical Institute
 - "for protection of health, wear scarves over your mouth and turn on the kitchen filters ", offical advice of Sarajevo Canton Public Health Institute
 - "some parents want to extend their New Year holidays", Sarajevo Canton Prime Minister, after we had requested closure of schools

December 2014., Protest in Zenica



December 2015., Air Pollution Episode

- Two months of high and persistent air pollution
- Public Debate on air pollution in Sarajevo, 19 December

December 2015., Air Pollution Episode



- For the first time in Sarajevo, citizens wearing masks. 22 December
- Schools closed, 23 December

December 2015., Air Pollution Episode - Aftermath

- Government response:
 - Sarajevo Canton
 - Air monitoring stations relocated to positions with cleaner air, next to the river, contrary to the existing recommendations.
 - Participation in District heating project (UNEP) used to shift attention
 - All other government levels all but ignored the problem

- 16 July, 2015.
 - Bihać City Assembly approved concession for construction of small hydroelectric plant in National park "Una"
 - 20 citizens protested in front of the Bihać City Hall
 - Conversion of rotten tomatoes to stones and its impact on decision making
- 23 July, 2015.
 - Bihać City Assembly reversed their decision


The battle won, but the war has continued...



Sarajevo Water Supply

- Year 2010: Sarajevo Canton Public Health Institute officially announced discovery of fecal bacteria in sources of city water supply.
- Apartments on Bjelašnica identified as source of pollution.
- Polluters did not pay 5 million Euros of public money spent so far to fix the broken sewage.
- Built without environmental permit.
- Buroj Ozone settlement for 40 000 tourists
- No environmental permit again.
- Investor driven planning New Cantonal Spatial Plan proposal to facilitate construction everywhere.
